Dearest CC Families,

Welcome to the 2021 dance season at Carolina Collective Dance Centre. First off, thank you for trusting us with your child in developing their passion for dance, their technique as a dancer, their teamwork skills, and cultivating their ambitious hearts. We don't take that lightly and greatly appreciate you trusting us with your child.

I know this has been an unusual time for our world with the COVID-19 pandemic, but I am so appreciative of how you've embraced our new policies for safety, adjustments to the new block scheduling system, cleaning/sanitizing procedures, and other changes. We will continue to get through this together and keep your child safe, encouraged and loved along the way.

You may have noticed that we will be continuing the block schedule system throughout this upcoming dance season. Our new season begins August 1, 2020 and ends May 31, 2021. Registration for this season begins this week. Payment will be due for the first month on July 25th. We bill on the 25th of the month for the following month.

Inside this packet you will find a new registration form, a new policy waiver that includes updates to our policies, a class schedule for you to circle which classes your child would like to take, and finally a payment form. All of this must be completed and returned to us in order to register your child for our season. At that time, we will be charging a \$25 registration fee per family.

This year we are requiring all dancers to have a payment method on file. With the size of our program now and our studio management software we must have a card on file for every dancer. I will be hosting a zoom meeting for all competition team parents this Friday at 3:30pm to go over our competition team packets. You will be receiving them prior to the meeting. If you are unable to make the meeting, a recording will be available.

I realize we are still a part of a global pandemic and this is a difficult financial time for many. Please reach out to me and I will gladly work with you as always to make sure we can find a way to keep your student dancing as we make it through this trying time. I am here for you. We are family. We will get through this together.

Thank you from the bottom of my heart for being a part of this dance family. I adore your dancer. I am so grateful I get to see them daily, help them grow, and to be able to love them with every ounce of my heart.

I am looking forward to this being the best season yet no matter what!

FEES & PAYMENT

- WE HAVE AN ANNUAL REGISTRATION FEE OF \$25 PER FAMILY.
- WE OFFER A 10% DISCOUNT PER SIBLING.
- TUITION IS DUE ON THE 25TH OF THE MONTH FOR THE FOLLOWING MONTH.
- TUITION IS PAID MONTH TO MONTH. THE FEE IS BASED ON FOUR CLASSES A MONTH. FOR MONTHS IN WHICH THERE ARE FIVE CLASSES, NO ADDITIONAL FEES ARE REQUIRED. CC FOLLOWS THIS SCHEDULE TO TAKE IN CONSIDERATION DAYS THE STUDIO IS CLOSED. IF CC IS CLOSED ON THE DAY OF YOUR CLASS, WE WILL ALLOW A MAKE-UP. CC DOES NOT PRORATE FOR STUDIO CLOSURES OR MISSED CLASSES.
- WE MUST HAVE A CREDIT CARD ON FILE TO PROCESS TUITION. DECLINED CARD FEE IS \$5. THERE WILL BE A LATE FEE OF \$5 PER WEEK ADDED IN THE EVENT THAT TUITION IS LATE. IF YOUR TUITION IS MORE THAN 30 DAYS LATE, YOUR ACCOUNT WILL BE PUT ON HOLD AND NO CLASSES MAY BE ATTENDED UNTIL IT IS BROUGHT UP TO DATE.
- OUR SEASON IS AUGUST 1- MAY 31. WE HAVE A SUMMER SESSION OF JUNE AND JULY.

CLASS PLACEMENT

- CLASS PLACEMENT IS SUBJECT TO CHANGE. DANCERS WILL BE ASSESSED ONCE A YEAR AND CLASS PLACEMENT IS SOLELY DETERMINED BY THE DISCRETION OF THE CAROLINA COLLECTIVE STAFF.

CURRICULUM

- OUR CURRICULUM IS CAREFULLY CRAFTED TO SHAPE YOUR DANCER'S TECHNIQUE IN THE MOST CURRENT INDUSTRY RELATED STYLE.
- OUR GOAL IS TO PROVIDE A WELL ROUNDED ENVIRONMENT FOR YOUR CHILD. ONE THEY CAN FEEL CONFIDENT ABOUT THEIR ACCOMPLISHMENTS AND GROW IN AN ENVIRONMENT FULL OF SUPPORT.
- WE ALSO BELIEVE PASSIONATELY ABOUT PRESENTING THEM WITH CHALLENGING CHOREOGRAPHY AND TECHNIQUE TO ALLOW THEM TO GROW TO THEIR MAXIMUM POTENTIAL.
- IF THEY CHOOSE TO PURSUE A CAREER IN DANCE OR ANOTHER FIELD- THE LESSONS THEY LEARN IN OUR STUDIO WITH DEVELOP THEIR CHARACTER AND STAY WITH THEM FOR A LIFETIME.

COVID-19
